

2020-2021 A la Carte Agreement Form

This form must be completed for all 7th graders, new students and/or families who wish to make a change to a prior signed agreement.

This Agreement will remain in place until withdrawn in writing by the parent/guardian.

Students in the elementary and high school are given the option of purchasing a la carte items (items sold separately and not as part of a complete meal). To help families control the cost of their meals, we are asking each family to complete this form. Students who do not have the completed form on file will not be allowed to purchase a la carte items using their family account.

- A 2nd lunch entrée will only be sold to those students who first purchase a complete reimbursable meal (meal must consist of at least 3 food groups including fruit and vegetable).
- A la carte charges will only be allowed for students who have this completed agreement on file, and who have a positive balance in their account.
- Students who bring cold lunch and wish to purchase milk should have money in their account.

NOTE: "Milk only" is not provided for free to students receiving free or reduced meals.

Elementary Students:

At breakfast, students have the option to purchase milk or juice separately, or a 2nd entrée.

At lunch, students have the option to purchase additional milk and/or a 2nd entrée.

High School Students:

At breakfast, students have the option to purchase milk or juice separately, or a 2nd entrée, as well as other items.

At lunch, students have the option to purchase additional milk or a 2nd entrée, as well as other items such as chips, cookies, cheese sticks, yogurt, Pop Tarts, etc.
